NOTIFICATION

It is notified for the information of all concerned that on the occasion of **550th birth Anniversary of Guru Nanak Dev** the Vice-Chancellor, in anticipation of the approval of the Academic Council, has desired to grant a special chance to the students of various courses who couldn't pass the course within the admissible chances as per ordinance, subject to fulfilment of following criteria/conditions:-

- (A) The students who enrolled himself/herself for their particular course in the year 2005 onwards and all his/her admissible chances/maximum duration of course as provided in the scheme of Exam stands availed/exhausted till the last exam i.e. May/June, 2019, shall only be eligible for this special chance. If anyone who has any admissible chance or still have time to clear the course to pass the degree at his/her credit, as of now, shall not be eligible for the special chance.
- (B) For this special chance there will be examination fee of Rs. 10,000/- per semester.
- (C) The students are also advised that before submission of online examination form and fee, they may check/ensure their eligibility and if they have any doubt, they can confirm it from the concerned Result Branch. If any **INELIGIBLE STUDENT/CANDIDATE** submit his/her examination form and fee without ensuring his/her eligibility, then he/she will be responsible for the same and the examination fee deposited by him/her will not be refunded by the University in any case. All the students are advised to read the following conditions/instructions carefully :-
- i) This special chance is admissible to complete the degree (course) for such students who have re-appear in one or more papers (subjects) and also for those who could not avail their admissible chance of improvement of division/marks.
- ii) The Examination forms along with Fee shall be filled up by the student directly, through online mode latest by **30.09.2019** for which **GJUST, Hisar** will open portal on university website. No examination form will be entertained/accepted after the cut-off date as **30.09.2019**.
- iii) The Examination for this special chance shall be got conducted tentatively in the month of **Nov/Dec, 2019** as per applicable scheme & syllabi of each course.
- iv) The schedule of examination/declaration of result will be depending on administrative requirement of the University and students will have no claim for early conduct of examination as well as declaration of results.
- v) For this Special Exam the Centre(s) of examinations shall be at GJUST, Hisar only.
