NOTIFICATION

The Vice-Chancellor is pleased to approve the following recommendation of the committee dated 04.01.2021 regarding examination in respect of affiliated Education Colleges of the University due to COVID-19 pandemic situation:

1. The students of First Year of B.Ed. and other Education Courses having yearly system may be promoted in their next higher class of their course due to COVID-19 pandemic situations and keeping in view of earlier guidelines issued by the University/State Govt. **The students may be awarded marks for Theory papers of 1st year of above said courses by considering 50% of Internal Assessment of above said course + 50% of cumulative score of their qualifying examination considered for admission in 1st year of B.Ed. and other Education Courses in the college for session 2019-20.**

OR

The students may opt to appear for examination of their Theory papers as per schedule/date-sheet notified by the University vide Endst. No. Condt./20/4265-74 dated 26.12.2020. The Principal of the colleges concerned will submit list of such students who are going to opt for examination of Theory papers to the Controller of Examinations of the University latest by 05.01.2021 at 4.00 pm.

2. The Practical examination of students of 1st year of B.Ed. and other Education Courses shall be conducted as per past practice of the University.
3. In case, any regulatory body such as UGC/NCTE/State Govt. etc. make question on the validity of marks/degree awarded to above said students, then such students will have to appear for examination of 1st year of their B.Ed. and other Education Courses. The Principals of Education Colleges have agreed and assured the University for compliance in above matter.
