ADMISSION NOTICE AGAINST VACANT (LEFT OVER) SEATS FOR THE SESSION 2017-18
M.PHARM. PROGRAMMES

It is notified for information of all concerned that the Counseling for vacant/ leftover seats in the following programmes of the University will be held on 14.08.2017 at 12.00 Noon in the respective departments:-

- (3) Detail fee structure of the courses is available in Chapter-8, "Fee Structure for the session 2017-18" of the University Prospectus uploaded on the University website.

These seats will be first offered to the candidates, as per the procedure/ criterion mentioned in the University Prospectus 2017-18. However, a brief procedure/ criteria to the vacant/ left over seats will be as under:-

1. The vacant seats will be offered to the GPAT qualified candidates who had applied earlier irrespective of category strictly on the basis of GPAT score.
2. After GPAT qualified candidates who had already applied, the remaining seats will be offered to candidates who have already applied and appeared in Entrance Test. For such candidates admissions shall be made strictly on the basis of the Merit of Entrance Test.
3. After admission of candidates who had already applied if seats remain vacant they shall be now offered to fresh GPAT qualified candidates present at the time of counseling who fulfill the eligibility criteria given in prospectus-2017.
4. If seats remain vacant even after offering the seats to fresh GPAT candidates, fresh non GPAT candidates present at the time of counseling, who had not applied earlier, may be given admission on the basis of Academic Merit of qualifying examinations.

Note: The candidates having supplementary/ compartment/ re-appear in the qualifying examination shall not be allowed for admission to any course in the University Teaching Departments.

Interested candidates may download the Admission Form from the University website www.gjust.ac.in and the same be submitted alongwith with a Challan Form of Rs. 1000/- for General Category and Rs. 250/- for SC,BC & EBP candidates of Haryana only in favour of Registrar, GJUS&T, Hisar payable at Hisar alongwith attested Photostate copies of all the documents mentioned in the University Prospectus to the Chairperson, Department of Pharmaceutical Sciences concerned by 11.08.2017 upto 10.00 a.m. The counseling will be held on 14.08.2017 at 12.00 Noon sharp in the respective department as per procedure mentioned in University Prospectus for the session 2017-18. The candidates will have to produce their original certificates to the Chairperson of the Department concerned at the time of counseling for verification and registration purpose and fee will be deposited at the spot.

Further, the girl candidates who have applied for admission to various UGC programmes in the University and could not tick the options for admission under single girl child scheme and also appeared in the entrance test conducted by the University, if otherwise eligible under this scheme, be also given an opportunity to be considered for admission in UGC programmes under single girl child scheme as per merit of entrance test examinations, where the seats are lying vacant during the counseling to be held on 14.08.2017 at 12.00 Noon sharp in the respective department as per procedure mentioned in University Prospectus for the session 2017-18.
