The above said provisional affiliation has been granted subject to fulfilment of following conditions by the college within two months:

1. The college is required to appoint qualified staff as per norms of State Govt./UGC/University. One Lab Attendent is also required to be appointed each for PG Diploma in Yoga and Mental Health (One Year Diploma) course and Functional English (Elective subject in B.A.) course.
2. A Reading Room of big size is required in Library of the college.
3. More Library books for the above said new subject(s)/course(s) of an additional amount of Rs. 2.0 Lac should be purchased by the college.
4. The college is required to spend additional amount of Rs. 2.0 Lac on purchase of Yoga equipments and other equipments. 20 more computers should also be procured in the college.
