NOTIFICATION

The Hon'ble Vice-Chancellor, on the recommendations of the committee constituted under the chairmanship of Dean Academic Affairs to frame rules regarding admission to Ph.D. programme for regular non-teaching employees of the university, has been pleased to approve following modalities for admission to Ph.D. programme for regular non-teaching employees:

1. Regular non-teaching employees, who are appointed through Executive Council (i.e.G.P. Rs. 5400/- on wards) shall be governed by the rules as prescribed for regular teachers of the University for admission purpose only.
2. Other regular non-teaching employees shall be governed by the rules prescribed in the prospectus of that year for Ph.D. admission. They have to appear in the entrance examination, however condition of passing of entrance examination shall not be imposed on these regular non-teaching employees of the University. Any kind of leave may be taken by such employees for the period/duration of Pre-Ph.D. course work.
3. Consent of the guide/supervisor is mandatory before applying for admission in Ph.D. programme by any of regular non-teaching employees of the University.
4. If non-teaching employees are more than one for one department, then the admission will be made on the basis of academic criteria prescribed in the Ph.D prospectus of that year.
5. Two seats be created for admission to Ph.D programme in Computer Science & Engineering, Mass Communication, Religious Studies and Management disciplines for non-teaching employees from the year 2016-17. This year (i.e. 2016-17) one seat each in Computer Science & Engineering and Management discipline may be allocated, next year i.e. 2017-18 one seat each in Mass Communication and Religious Studies discipline will be allocated on rotation basis.
