A meeting of the Research Promotion Board was held on 10.07.2018 at 3.30 pm under the Chairmanship of Hon'ble Vice-Chancellor. The following members were present:

The following were discussed and approved:


1. It was decided that all the information related to publications and research projects for the last 3 years be put on the university website.
2. It was further decided that all faculty members will create their Google Scholar and/or ResearchGate Account with Public profile.
3. It was resolved that every research scholar shall publish at least two research papers before the submission of Ph.D thesis and should also submit the published paper along the Ph.D thesis and atleast one of them should be in refereed reputed Journals.
4. Each research scholar shall include one paragraph citing relevance of the project from national context in the Ph.D thesis. The acknowledgement should also be included in the Ph.D thesis.
5. It was resolved that a D.O. Letter should be sent to DST, Govt. of Haryana for raising the financial limit of research projects upto Rs.25 lacs & DST Haryana be also suggested to raise the limit of Travel Grant, Registration Fee, Visa Fee, Accommodation Charges upto Rs.1.00 lacs for participation in international conferences/ workshops.
6. It was resolved that the existing University Research Scholarship of Rs.8000/- be given on the basis of merit drawn based on 50 % weightage of Pre Ph D course and 50 % of Qualifying exam w.e.f. the date of declaration of Pre Ph D Course result.
7. It was resolved that the contractual faculty members should be encouraged for carrying out research work in collaboration with senior faculty members of the concerned Department and they may publish atleast one research paper in SCOPUS data base.

8. Application of Dr. Sandeep Kumar, Dept of Bio & Nano Technology for grant of leave for a period of 6 months was considered, keeping in view the importance of this prestigious fellowship.

"It was resolved that Dr. Sandeep Kumar be awarded duty leave for a period of 6 months as a special case w.e.f August 8 2018 to Feb. 8 2019.

(It is mentioned that Dr. Sandeep Kumar was not a part of this decision".)

9. A committee comprising of Prof S.C. Kundu, Prof. Neeraj Dilbaghi and Director IQAC was constituted for recommendation related to Research Awards and Incentives for state and national/ International level recognition in Research to the Faculty members and Research scholars.
