NOTIFICATION

The Vice-Chancellor, after considering the concession letter of Central/State Govt. for the Wards of Kashmiri Migrants, is pleased to allow the relaxation in cut off percentage upto 10% subject to minimum eligibility requirements for admission to various courses as mentioned in the University Prospectus 2019-20, Chapter-4 "Eligibility for Admissions", for admission to the Wards of Kashmiri Migrants students under Supernumerary Seat, under Section 11(5) of the University Act, 1995, in anticipation of approval of the Academic Council/Executive Council. The existing and amended rules in this regard is as under :-

Existing	Amended
Clause-2 Academic qualifications for admission to various programmes run by this University shall be the same as mentioned in the Chapter-4 "Eligibility for Admissions".	Clause-2 Relaxation in cut off percentage upto 10% subject to minimum Eligibility requirement for various courses as mentioned in the Chapter-4 "Eligibility for Admissions" of University Prospectus 2019-20.

The same procedure for calculating the relaxation in minimum eligibility for admissions of Wards of Kashmiri Migrants will be the same as mentioned at Clause-8 of "Other important information/notes related to Eligibility/Admissions" Chapter-4 of the University Prospectus 2019-20.

Further, the Vice-Chancellor has also approved that the fresh applications for the Wards of Kashmiri Migrants and North Eastern candidates be invited for the courses, where the Supernumerary seats of above categories are still lying vacant for the academic session 2019-20 and the admissions in case of Wards of Kashmiri Migrants be made as per above relaxation in cut off percentage. Other rules/procedure, as mentioned in the University Prospectus 2019-20, will be applicable for admission to above categories.
