As per instructions Revision of House Rent Allowances admissible to Haryana Government Employees under 7<sup>th</sup> CPC the following categories of employees are required to submit 'House Rent Form' and 'Certificate' (Format Overleaf):-

- 1. Employees who are living in their own house.
- Employees, who are claiming HRA of Rs.5000/- & above are required to submit a rent receipt alongwith address proof in the office & those who are claiming HRA of Rs. 10000/- and above are required to submit a copy of PAN CARD as well as rent receipt.

The above documents are required to be submitted, along with the absentee statement in the month of Jan ,2020 of each year i.e. up to 20<sup>th</sup> Jan. Accordingly, it is requested that the employees working in your office/Deptt., may be asked to submit the required document (referred as above) immediately and the same may be forwarded, along with the absentee statement of Jan, 2020, failing which it will not be possible to draw the house rent allowance from Jan, 2020 and onwards in respect of the concerned employee(S).
